Diversity Dinner

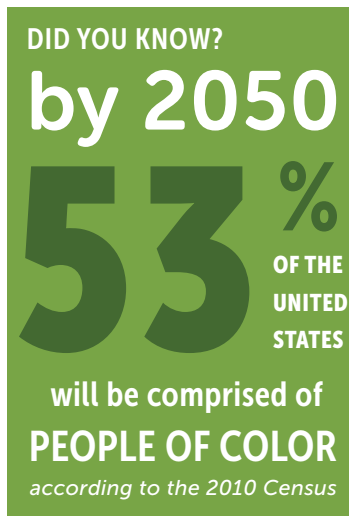
The Annual Diversity Dinner is a fun evening of networking, cultural performances, and a celebration of diversity in the city.
